Eligibility:

- Only students who are from Madison County are eligible.
- In the case of students at the University of Alabama or the Cumberland School of Law, only students who have received a letter of acceptance are eligible to receive the scholarship. In the case of students at the Jones School of Law or the Birmingham School of law, only first-year students or those who have received letters of acceptance from these institutions are eligible. Second- and third-year students are not eligible for this scholarship.

Application must include:

- An unofficial or official copy of college transcript(s).
- A résumé.
- A letter of acceptance from a law school.¹
- A recent photograph if you have one available.
- The following information:
