

National Moot Court Teams

Congratulations to our national moot court teams who represented Cumberland on Nov. 6-7, 2009. **Drew Herring, Hannah Mebane, and Leslie Palmer** represented Cumberland at the National Health Law Moot Court Competition at Southern Illinois University School of Law in Carbondale, IL. The team selected to compete at the NYC City Bar National Moot Court Competition - **Jordan Beard, Charles Elliott, and LaKeita Rox**--advanced to the quarter-finals held at the Alabama Judicial building in Montgomery.

The health law team argued whether the Emergency Medical Treatment and Active Labor Act (EMTALA) was violated when a medical center sought to transfer an undocumented immigrant under its care to a medical facility in her home country, and whether the medical center, as an instrumentality of a state, had Eleventh Amendment immunity from suits brought in federal court under EMTALA. The NYC City Bar competition team argued whether juveniles should be categorically exempt from sentencing to life imprisonment without the possibility of parole and what is the appropriate standard for a change of venue based on pretrial publicity.

Many thanks to Sims Moot Court Board Chief Justice **T.J. Schaffer**, to **John Coke**, the Board's national team coordinator, and to **Tracy Luke**, for their tremendous efforts to organize and prepare the national teams for competition. **Professor Nelson** also assisted the health law team with its preparations; **Professor Snoe** traveled with the team to Illinois. **Professor Davis** accompanied the NYC City Bar team to Montgomery.

Congratulations to all of Cumberland's moot court team members for their dedication to strong oral advocacy and brief writing skills and many hours of preparation.

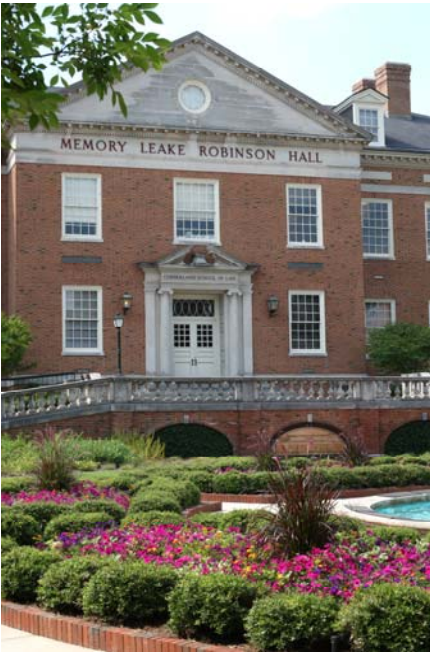
Faculty Colloquium

Course/Faculty Evaluations

The law school will be conducting course and faculty evaluations November 9 -13. Having students complete these evaluations each semester is critically important to the law school. Faculty use the evaluations to improve their classes and teaching and to identify problems that require action. We thus strongly urge all students to take a few minutes to complete evaluations for each of their courses.

Like last semester, evaluations will be online. The online responses are entirely confidential, as there is no way to identify the author of any submitted evaluation. The system requires students to log in only to assure that each student completes only one evaluation per course.

Beginning November 9, therefore, we ask that all students complete evaluations for each of their courses. To complete evaluations, simply access the law school website from any internet connection, click "2009F Evaluations," and follow the instructions. SBA representatives will be visiting all classes beginning November 9 to facilitate online

evaluations in class. However, students are free to complete evaluations outside class on any computer.

All students in classes which achieve a 75% response rate by noon on November 16 will eligible for a **pizza party** to be held on November 18.

Exam Information

Fall semester exams are scheduled to begin on **November 30**. While complete exam instructions are posted to the web under the Academics tab, students should particularly note the following:

Exam Software: Students who will use laptops must download the new *Extegrity* software between November 16 and 29. All previous versions of the software have expired. By November 29, students must use the computer they will use on exams to create a practice exam and submit it wirelessly. When preparing a practice exam to submit, students should choose "F09 Practice Exam" from the course drop-down list.

Extegrity now has an "Open Mode" feature that permits the test-taker to access the computer's internal hard drive. "Open Mode" exams are allowed only when specifically instructed by the proctor. Use of "Open Mode" during a "Closed Mode" exam constitutes cheating.

Alternate Exam Times: Students do *not* have a right to take exams at times other than the regularly scheduled times (unless they have 3 exams on the same day). However, students may take an exam at one of the scheduled alternate exam times if (i) their professor gives permission by November 19; and (ii) the professor timely submits the required alternate exam envelope and materials. Students having permission to use an alternate exam time should consult the list outside the Associate Dean's Office after November 20 to confirm that their professor submitted the materials.

Exam Day Arrival: Students should report to their exam rooms 15 minutes before the scheduled start time and follow the directions written on the board.
